# THE MANAGEMENT AND OPERATION OF CONTAINER TERMINAL B3 AT LAEM CHABANG PORT

This Contract is executed and delivered this 25th day of November 1994 at Laem Chabang Port, Toong Sukhla, Sri Racha, Chonburi 20230 between the Port Authority of Thailand represented by Mr. Thavorn Chunnanond, Deputy Director General (Administration), Acting Director General (hereinafter called "PAT") of the one part and Eastern Sea Laem Chabang Terminal Co., Ltd. incorporated under the law of Thailand with its registered business office at 250 Sukhumvit 68 oi Sophon), Sukhumvit Road, Kwang Bangna, Khet Prakanong, Bangkok Metropolis 10260, Thailand, represented by Mr. Vichien Vithoontien and Mr. Yoshihide Hoshino (hereinafter called "the Terminal Leasing Company" or "TLC") of the other part.

Documents evidencing such registration of the Terminal Leasing Company and the authority of the person to sign on behalf of the Terminal Leasing Company are attached hereto together with two bank guarantees, the first as a Performance Guarantee in the amount of 30,000,000 Baht (Thirty Million Baht) and the second as a Lease Guarantee in the amount of 82,000,000 Baht (Eighty Two Million Baht).

The Port Authority of Thailand and the Terminal Leasing Company agree as follows:

The PAT hereby allows and the TLC hereby agrees to lease the Container Terminal B3 at Laem Chabang Port to further develop, manage, and operate according to the terms and conditions as laid down in this Contract and its Appendices.

The TLC agrees to perform efficiently and faithfully all of the Services described in this Contract and its Appendices including the mobilisation of requisite staff, labour and equipment.

The TLC is allowed to retain revenues for the services it provides against a payment to the PAT as specified in the terms and conditions of this contract and its Appendices.
