Contract 3: Elevated Civil Works Tao Pun – Tha Phra Section

This Contract is made at the Mass Rapid Transit Authority of Thailand, 175 Rama IX Road, Huay Khwang, Bangkok 10320 on 17 day of February B.E. 2554 (A.D. 2011) between:

(1) MASS RAPID TRANSIT AUTHORITY OF THAILAND

by Mr.Ronnachit Yaemsaard, the MRTA Acting Governor, with office located at 175 Rama IX Road, Huay Khwang, Bangkok 10320, hereinafter referred to as the "MRTA" or the "Employer", as the case may be, of the one part and;

(2) SH-UN JOINT VENTURE

Comprising of Sinohydro Corporation Limited and Unique Engineering and Construction Public Company Limited, with its office at 200, Jasmine International Tower, 15th Floor, Moo 4, Chaengwattana Road, Pakkred, Pakkred, Nonthaburi, 11120, Thailand (hereinafter called "the Contractor") by and through their authorized representatives of the other part.

WHEREAS the Employer is desirous that certain Works should be executed by the Contractor, viz, the construction of Elevated Structure at Tao Pun – Tha Phra Section with precast segmental box girder viaduct of approximately 11 km. in length, elevated approximately 17 meters above existing ground; with the construction of 8 elevated stations, architectural works and building services within the station, and the intermodal transfer facilities (ITF), a railway bridge crossing the Chao Phraya River and other works as defined in the Contract, and has accepted a Tender by the Contractor for execution and completion of such Works and the remedying of any defects therein.

Now this Agreement witnesseth as follows:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Contract, viz;

 - Volume 3 The Tender and the Appendix to Tender;

 - Volume 6 The Drawings; and
 - Volume 7 The Specifications
- In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Employer hereby agrees and covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
