This Agreement made this 3 day of April B.E. 2558 (A.D. 2015) between Mr. Peerayudh Singpatanakul, the Governor of the Mass Rapid Transit Authority of Thailand, Ministry of Transport, Government of the Kingdom of Thailand (hereinafter called "the Employer") of the one part and Mr. Natee Panichewa and Mr. Huang Zheng and Mr. Shuai Lihua of UN-SH-CH Joint Venture (hereinafter called "the Contractor") of the other part.

 - (e) The priced Bill of Quantities;
 - (f) The Drawings;
 - (g) The Specifications;
 - (h) The Contractor's Proposal
- In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.

4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and remedying of defects therein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
